The Tanzanian Children's Fund provides direct support to Rift Valley Children's Fund (RVCF) in Oldeani, Tanzania, whose primary objective is to support marginalized children living at the Rift Valley Children's Village (RVCV) in the Karatu District of Tanzania. To this end, the Rift Valley Children's Village serves as a permanent home to 97 children, in addition to providing support to 14 Kids Living with Relatives. RVCF also runs community-based programs designed to raise the standard of living for the entire community and create a healthy and nurturing environment for all children to grow up in. These programs include partnerships with the local primary and secondary school (476 and 371 students respectively), a microfinance program serving 620 active clients, and a community rural health clinic.
